VAKSINASI GOTONG ROYONG (VGR)

<u>Gotong Royong Vaccination Programme (VGR)</u>

• Vaccination for employees, their family member(s) and other individuals related to their family which is funded by their company. The expense will not be charged to vaccine recipients.



<u>Purposes of COVID 19 vaccination (article 4):</u>

- Reducing the transmission/spread of COVID-19
- Reducing the infection rate and death toll
- Achieving herd immunity
- Protecting people from COVID-19 to improve productivity



VAKSINASI GOTONG ROYONG (VGR)

VGR will not disturb the RI Government Vaccination Programme (VP)

- Type of vaccine cannot be the same as the one(s) used by the RI Government VP such as SinVac & AstraZeneca. As of now, Bio Farma has approached Sinopharm & Moderna.
- Time of implementation VGR will be executed once the (selected) vaccines are available. The procurement of vaccine is managed by the Ministry of SOEs-Bio Farma (Ministry of Health - MoH).
- Health facility for VGR must be private health facility, not public health facility that conducts RI Government VP. Legal entity that has a health facility which fulfils all requirements from the Ministry of Health may conduct VGR.

<u>VGR Requirement Plan</u>

- This serves as a reference for COVID-19 vaccine procurement, supporting equipment and required logistics.
- Business entity must report to the Ministry of Health on the number of employees (and family members) who will be vaccinated. The report must contain the following:
 - Number of target
 - Name
 - Address
 - Citizenship ID Number (NIK) this is to crosscheck against the VP data


Priority Groups of COVID-19 Vaccine Recipient

- Health workers
- Geriatrics & public service workers
- Vulnerable community based on geospatial, social and economic aspect
- Other community

Each person may only be registered under one category. Currently, RI Government still focuses on the 1st and 2nd priority group. It is hoped that VGR would accelerate the vaccination process in the country.

















VAKSINASI GOTONG ROYONG (VGR)

Standard of Service

<u>Executor (article 22)</u>

- May only be conducted at privately-owned health facility that fulfil all requirements.
- The health facility(s) is not used for VP.
- VGR is executed through a cooperation between business entity and private health facility. It is hoped that an existing partnership/collaboration would ease the preparation process especially from the Government side. Bio Farma could give a recommendation to business entity on available and eligible local health facility if needed.
- Business entity that has a health facility may conduct VGR at their own health facility.
- Business entity must coordinate with the local Health Department at city/regency level.



















VAKSINASI GOTONG ROYONG (VGR)



<u>Cost (Article 23)</u>

- The maximum cost of VGR service is stipulated by the Ministry of Health. The number is still under review.
- VGR service cost may not exceed the maximum cost stipulated by the Ministry of Health.

<u>Standard Operation Procedure (Article 31):</u>

• VGR protocol is based on the Standard Operation Procedure (SOP) that is stipulated by the head of health facility in accordance with the technical guidance of vaccination.


Vaccination Certificate (Article 32)

• Everyone who has been vaccinated will receive an electronic vaccination certificate.

















VAKSINASI GOTONG ROYONG (VGR)

<u>Requirements for health service facility (article 24)</u>

- Availability of health workers (doctor, nurse, midwife)
- Cold-chain facility based on the type of vaccine to protect the quality of vaccine as it is very sensitive (Sinopharm: 2-8 degree Celsius)
- Have an operational license for health facility

Having an operational team that has the following functions: (article 28)

- Registration/verification
- Screening, physical examination, providing education and informed consent
- Preparation and administration of vaccine
- Post-vaccination observation (ensuring the vaccine recipient does not have adverse events following immunization (AEFI)), providing vaccination completion sign and vaccination certificate
- Record and input the vaccination result data to be integrated to VP data via Peduli Lindungi and Sistem Informasi Satu Data (managed by the Ministry of Health)
- Medical waste management
- Arranging good flow of service preventing crowd which might create a COVID-19 cluster















VAKSINASI GOTONG ROYONG (VGR)

<u>Adverse Events Following Immunization (AEFI)</u>

The management protocol for VGR is the same as VP which is covered by RI Government as follow (Article 35)

- Health Facility and Health Department will record, report and investigate.
- Field Etiology Studies by Regional Committee of Examination and Management of AEFI (KOMDA PP KIPI) and Causality Studies by National Committee of Examination and Management of AEFI (KOMNAS PP KIPI).
- If the result of causality studies indicates vaccine as the cause of AEFI, BPOM will conduct sampling and examination.
- If required, AEFI will receive medical care based on the medical indication and treatment protocol.

VAKSINASI GOTONG ROYONG (VGR)

<u>Recording and Reporting (Article 42)</u>

- Health facility must conduct recording and reporting.
- This is done electronically via Sistem Informasi Satu Data.
- If the health facility is not connected to the system then
 - Manual recording
 - Delivering report to local Health Department at city/regency level.
 - Input to Sistem Informasi Satu Data via local Health Department

<u>Funding (Article 43)</u>

- Funding of VGR is charged to business entity.
- Funding of AEFI Monitoring and Management is covered by state budget and expenditure.
- Funding of medical care for AEFI sufferers is charged to:
 - Ministry of Health budget, or;
 - National Health Insurance Programme managed by Health BPJS.







Guidance and Supervision (Article 44) of Minister of Health Regulation no. 10 (2021) is conducted by:

- Ministry of Health
- Ministry of Finance
- Ministry of Foreign Affairs
- Ministry of State-Owned Enterprises
- Ministry of Domestic Affairs
- Ministry of Communication & Informatics
- Judiciary
- Indonesian National Army (TNI) / National Police of the Republic of Indonesia (POLRI)
- Supervisory Board of Drugs and Food (BPOM)
- Supervisory Board of Finance and Development (BPKP)
- Committee of Corruption Eradication (KPK)
- National Public Procurement Agency (LKPP)
- Health Department at Province and City/Regency level













Process Flow of Mutual **Cooperation Vaccination**

State Owned Enterprises (SOE)/Regional SOE send a letter to Pharmaceutical Holding SOE (Bio Farma)

Bio Farma submits data of Private SOE/Regional SOE to MoH (by name, by address, number and health facility suggestion)

Private Business/Legal Entity send a letter to Indonesian Chamber of Commerce and Industry (KADIN)

KADIN submits data of Private Business/Legal Entity to MoH (by name, by address, number and health facility suggestion)

MoH determines Business/Legal entity that will receive vaccine (allocation), and health facility*



MoH informs Business/Legal entity and allocation to Bio Farma

Bio Farma conveys information on allocation to KADIN and companies

Vaccination Preparation Distribution by Bio Farma Vaccination Schedule by health facility and Business Entity

Further Information from Live Questions:

- Regardless the number of employees, all vaccination recipients from private sector for VGR MUST BE registered via KADIN. Bio Farma and/or its branches do not receive direct registration from private sector.
- Company may retract their VGR registration later if they do not have sufficient resources.
- Family members of employee are not compulsory to be registered under VGR.
- As of now foreign nationals in Indonesia is not included in the priority groups. Bio Farma has discussed this issue with MoH in their recent meeting. It is advised to register foreign nationals in VGR should there are changes in the future.
